### **Reflections on the Lilongwe Gathering:**

#### **Discussions on Crisis and Resilience**

#### Introduction

# 3. Crisis in Social and Relational Struggles:

- Emphasis on the church's role in fostering community relationships and addressing social conflicts.
- O Actionable steps involved organising seminars on marriage and relationships, promoting inclusive environments to reduce social isolation, and engaging in community activities that encourage social cohesion.





# 4. Crisis on Identity and Emotional Wellbeing:

- O Discussion on the church's role in supporting mental and emotional wellness.
- O Practical measures included implementing discipleship and counselling focused on identity and self-worth, encouraging physical activities to boost mental health, and facilitating platforms for social interaction to combat isolation.

## **Key Takeaways for Further Reflection:**

- The need for ongoing training and education within the church to address both spiritual and societal issues effectively.
- The importance of inclusive practices that embrace all community members and encourage active participation in church-led initiatives.
- The potential for church leaders to play a pivotal role in shifting cultural norms towards healthier community practices.
- Acknowledgement of the church as a place of refuge and support in times of personal and community crises.
